

STUDENT ENRICHMENT GRANTS

The goal of the Student Enrichment Grants is to provide funds for students in grades K-12 to participate in experiences that extend beyond the classroom. The experiences may include but are not limited to the following:

-Tuition and fees for 5th grade students to participate in Camp Grady Spruce

-Summer Academies such as Debate, Fine Arts, Leadership, Math, NASA Space Camp, Robotics, SAT/ACT, Science, etc.

APPLICATION GUIDELINES

Grant Application must be typed for consideration.

<u>Please read carefully to fully understand guidelines and expectations.</u>

Award Range:

- Up to \$2,000/Student between September 1 and August 31 of each year
- The number of grants funded will depend upon available funds.

Application Deadline: 45 days prior to the required funding

Notification of Recipients and Awarding of Funds:

- Recipients will be notified within 30 days of application submission.
- Funds will be sent to the vendor sponsoring or hosting the activity.

Applicant Eligibility:

- Student Enrichment Grants for Students are limited to students in the Ponder Independent School District schools who would like to participate in enrichment activities that are above and beyond regular, remedial or required study.
- A letter of recommendation is required for all enrichment applications except for Camp Grady Spruce.
- If students do not attend the enrichment activity 85% of the time, parents are responsible for reimbursing the Ponder Education Foundation and will not be eligible to apply for another Foundation grant for one year.
- A participation certificate verifying attendance must be submitted to the Foundation, plus a summary report at the conclusion of the activity.

Eligible Projects:

- All Enrichment grants must provide the applicants with information that will enrich the students' total learning experiences.
- Students are responsible for maintaining their school's expectations, and enrichment activities in no way supersede the school's curriculum.

Application Review:

• Before the applications are reviewed by the Programs Committee, a Ponder Independent School District campus administrator and/or counselor will review the applications for the express purpose of assuring student compliance with the criteria of the Student Enrichment Grants program.
