

# STUDENT ENRICHMENT GRANT

## Dual Credit – McMurry 2024-25

One goal of the Student Enrichment Grants is to provide funds for students in grades 11-12 to participate in Dual Credit courses. The following items are eligible for the grant(s): Tuition, textbooks, and fees.

### APPLICATION GUIDELINES

*Please read carefully to understand guidelines and expectations.*

**Application Deadline(s):** Fall – August 28<sup>th</sup> / Spring Nov. 15<sup>th</sup>

If this date falls on a weekend it will be due the Friday prior.

You need only apply once during a school year. If you apply for assistance for the fall and wish to receive the grant for the spring as well, you do not have to reapply. Be sure to request the appropriate amount of funds for both semesters.

**Award Range:** The cost for each class is \$200, or in the case of science classes, \$300.  
You may request an amount up to the total cost based on the number and kind of classes you take.

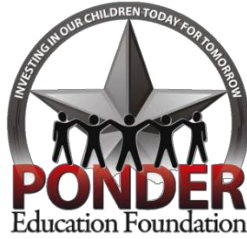
**Funding:** Funds will be sent to the college

#### Requirements:

- Application must be typed in order to be considered.
- Mail 2 copies of the entire application, along with a letter of recommendation, to: Ponder Education Foundation, 400 W. Bailey Street, Ponder, TX 76259. Do not fax or email.
- Must maintain a 3.0 average in all dual credit classes to remain eligible for future Dual Credit grants.
- Must return the Summary Page and an official transcript within 2 weeks of the end **of each semester** to remain eligible to receive grants in the future.

#### Notification of Recipients and Awarding of Funds:

- Recipients will be notified within 30 days of application submission.
- Only one application per applicant will be accepted per semester.
- The number of grants funded will depend upon funds available. Special consideration will be given to those with greater financial needs

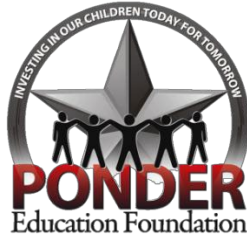

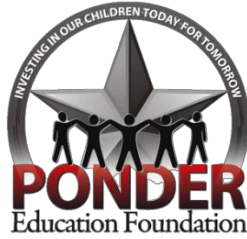

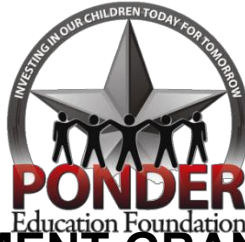
